In doing so, he uncovered a key detail: the debtor had listed a former address for the creditor, preventing his client from receiving the notice in a timely fashion. This was an important piece of information because it allowed Jason to file a motion to allow the claim, showing good cause for the delay. By uncovering this small detail, Jason was able to collect 100% of his client's claim — resulting in more than \$20,000 in recoveries.

Jason is a Major in the U.S. Army Reserve and is a decorated Veteran of both Iraq and Afghanistan; first as an administrative law attorney with the Multi-National Corps Iraq Headquarters at Camp Victory, and later as a contract and fiscal law attorney with the 645th Regional Support Group at Kandahar Airfield.
